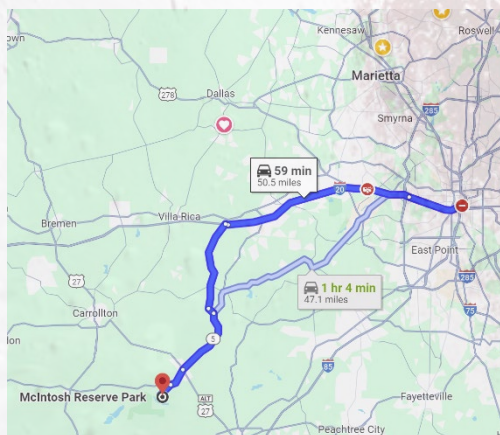

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets may be entered in the regular stakes.

Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record that has met the certification requirements.  
**FIELD CHAMPION STAKE:** Any ASFA Field Champion  
**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years, record that has obtained met the certification requirements.  
**PROVISIONAL STAKE:** Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.  
**SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field.

**LURE CHASING INSTINCT (LCI) STAKE:** Open to NON sighthounds and sighthound mixes that have earned 20 lifetime ASFA points. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC or ASFA number.  
**Small Open:** for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.  
**Small Excellent:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.  
**Small Veteran:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.  
**Large Open:** for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.  
**Large Excellent:** is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.  
**Large Veteran:** for dogs over 17-1/2 inches at the withers who are over the age of 7 years.  
**Sighthound Mix Open:** for dogs with a sighthound breed in its background who have not achieved the title of LCC.  
**Sighthound Mix Excellent:** for dogs with sighthound breed in its background who have achieved the title of LCC.  
**Sighthound Mix Veteran:** for dogs over the age of 7 years with sighthound breed in its background.

All entries must be one year of age or older on the day of the Trial. LCI is offered on Saturday & Sunday, limit of 10 entries per day.

BEST IN FIELD WILL BE OFFERED BOTH DAYS

**Conditions of Entry:** All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

**Equipment:** Type of lure machine: battery-powered continuous-loop system. Type of lures: highly visible white plastic strips. Back-up equipment will be available.

**PLEASE NOTE:** The Field Trial Chairman may also excuse, or levy and collect a penalty fee of \$5 from the owner or the duly authorized agent of any hound that is loose on the field and not in competition at the time.

## *For First Time Coursers and Handlers*

- **WHAT ARE PRE-ENTRIES?** - Entries made before the closing date. If your entry is mailed in time yet due to the failure of the postal service it is not received in time for the Field Trial Secretary (FTS) to have it at the Event, then you will have to fill out day of entry forms on the day of the trial. Always have your dog's registration materials with you when you go to a Trial.
- **WHAT ARE "DAY OF" ENTRIES?** - Entries accepted after the closing date for pre-entries are considered Day of Entries. The deadline for pre-entries is typically two days before the event. "Day of" entries are usually more expensive because the Field Trial Secretary (FTS) must take extra time to add those entries to the record sheets the morning of the trial, which delays the start of the trial. If you are entering on the day of the trial, you **MUST** have your completed entry to the Field Trial Secretary (FTS) **BEFORE** Roll Call.
- **SLIP LEADS** - There is a type of collar for coursing called a slip lead, which is worn only to control the dog prior to release. The collar drops away as the dog is released to chase the lure and they run without anything around their necks that could be dangerous. **SLIP LEADS WILL BE PROVIDED.**
- **INSPECTION** - Dogs will be inspected by a designated Inspection Committee consisting of at least two persons who are members of the Field Committee and who shall inspect each entered dog for lameness, fitness to compete and female estrus (in season). Inspection shall take place prior to any form of wrapping being applied to the dog. In the opinion of the Inspection Committee, any entry found to be lame, unfit to compete or in season shall not be allowed to enter and the applicable entry fees shall be refunded.
- **ROLL CALL** - The time, prior to the commencement of coursing, by which you are supposed to have your dog ready for inspection by the Inspection Committee. At roll call the dog is examined for lameness, and breed disqualifications (where applicable). Unspayed bitches are examined to see if they show any evidence of being in season. After roll call the list of passed hounds is taken to the Field Test Secretary so that the run order can be prepared.
- **RUN ORDER LIST** - This is a posted list of the running order for the dogs participating in the event. Always check the record sheet after the Roll Call to confirm your dog's running order and blanket colors.

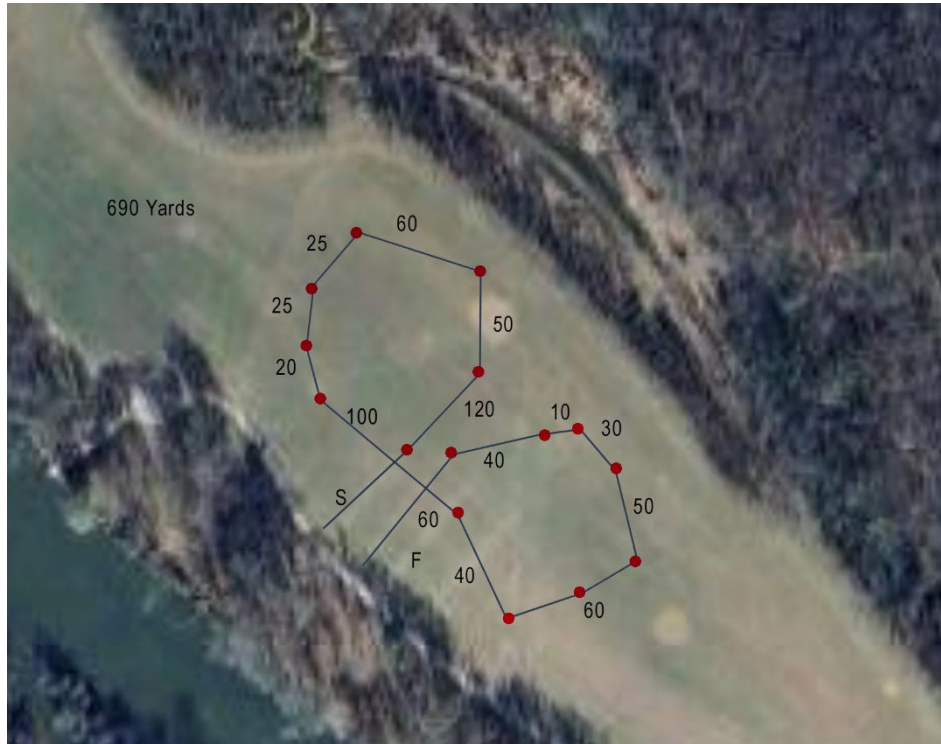
## *Park Rules and Regulations*

### **PARK STAFF RESERVES THE RIGHT TO ASK ANYONE TO LEAVE THE PARK AT ANY TIME FOR ANY REASON. NO REFUND WILL BE GIVEN.**

- **Pets:** Pets are welcome at Carroll County Parks if leashed (no longer than six feet) and accompanied by the owner at all times. No dog runners allowed. No tying pets to trees. Owners should clean up after pets.
- **Intoxicants:** Consumption or use of alcoholic beverages or intoxicants is unlawful in any public-use area.
- **Campfires:** All campfires must be kept in designated areas such as a fire ring. Never leave a campfire unattended. Smaller fires with coals (rather than large flames) are better for campfire cooking and toasting marshmallows.
- **Collecting:** All wildlife, plant life, driftwood, artifacts and any other natural or man-made features are protected and may not be disturbed or removed. Please leave wildflowers for other visitors to enjoy. Possession of metal detecting equipment is prohibited. No hammocks, dog runners, etc. to be anchored to trees.
- **Motor Vehicles:** Park roads are public roads. All vehicles are subject to license safety requirements and regulations of the Georgia Department of Public Safety. ATVs and golf carts are not allowed.
- **Noise Levels:** Please be considerate of guests who are visiting the park for a quiet, natural experience. Radios, televisions, musical instruments and all other noise-making devices are not to be used between 10 p.m. and 7 a.m. and must be kept at low volumes during other times. **NO PA SYSTEMS, NO DJs, & NO LIVE BANDS ALLOWED.** Noise levels must be contained to the area that you have reserved **ONLY.** If any complaints of noise levels are made, you will be asked to turn music **OFF** completely. Failure to do so will result in you forfeiting your reserved area, and you will be asked to leave premises. Music content **MUST** remain family friendly without vulgar language or explicit content. **NO REFUNDS.**
- **Visitors:** Visitors are welcome; visitors must leave prior to closing times.
- **Weapons:** Bows and arrows, explosives, fireworks, slingshots, fishing spears or any device that discharges projectiles by any means is prohibited. Firearms must be unloaded, cased and stored, unless a person possesses a valid weapons-carry license for a firearm that is valid in Georgia.
- **Camping:** Campers are welcome to stay a maximum of 5 nights, and then must leave the park for a minimum of 3 weeks. (There are **ABSOLUTELY NO EXCEPTIONS** to this rule! Those attempting to "cheat the system" will be banned from **ALL** Carroll County Parks for life.) Campers are allowed to have a maximum of two tents and up to six people per paid site. You are welcome to have more in the same area, but are required to pay for additional sites.
- **Pavilions:** Pavilions are by reservation **ONLY.** Anyone setting up without a prior reservation will be asked to move. All vehicles **MUST** purchase a parking pass.
